47 **NEW BUSINESS: 7a) Discussion Consideration and Action on Approval of**
48 **Agreement for Acquisition of a License to use Personal Property El Pueblo Health Service.**
49 **Presenter: Maria Rinaldi**

50 This agreement, dated this 23 day of February, 2009, supersedes the earlier agreement entered
51 into between the Town of Bernalillo (The "Town") a New Mexico municipality, and El Pueblo
52 Health Services, Inc. (The "Center") a New Mexico nonprofit corporation, on the 13th day of
53 November, 2006,

54 The Parties agree as follows:

55 The New Mexico State Legislature has appropriated the following amounts for the purposes
56 indicated: \$250,000 in severance tax bond proceeds "to plan, design, construct, furnish and
57 equip a radiography suite at El Pueblo health services in Bernalillo in Sandoval County "to
58 purchase and install a radiology machine for El Pueblo health center in Bernalillo in Sandoval
59 County", and \$75,000 from the state general fund " to plan design, construct, furnish and equip a
60 radiography suite at El Pueblo Health Services in Bernalillo in Sandoval County.

62 The Center is a non-profit New Mexico corporation providing medical services to residents
63 within the Town of Bernalillo, Sandoval County, as a designated federal government health
64 center look-alike. The Town has determined that the Center is the sole source provider of the
65 service to be rendered under this Agreement within the area to be served.

67 Councilor Sisneros moved to approve the El Pueblo Health Center Agreement for
68 Acquisition of and License to use Personal Property (MOU). The motion was seconded by
69 Councilor Torres and the motion carried unanimously.

70
71 **FINANCIAL SECTION: 8a) Approval of Account Payable List.**

72 Councilor Jaramillo moved to approve the Accounts Payable List totaling \$760,774.62 as
73 presented. The motion was seconded by Councilor Torres and the motion carried unanimously.

76 Stephen Jerge gave a update on state and federal initiatives.
