74 **MISCELLANEOUS SECTION: 9a) Update on the Utility Amnesty Program.**

75 **Presenter: Juan Torres**

76 Juan Torres, Interim Town Treasurer stated that on June 14, 2010 late notices were sent out with  
77 a disconnection notice of July 1, 2010. 524 notices were sent out. Since then, 397 customers  
78 have come in and made arrangements or paid in full, which is 76%. That leaves 127 customers  
79 with water shut off. Roughly \$430,000 has been collected. Other benefits we have discovered  
80 during this process are several addresses had broken meters, leaks have been found, and several  
81 illegal taps. We are letting customers know that we will work with them and set up a contract  
82 for their unpaid water bills.  
83

84 Mayor Torres acknowledged all the staff for the work they have done. It has been a great  
85 success.

86 **MISCELLANEOUS SECTION: 9b) Update on 4<sup>th</sup> of July Festivities. Presenter: Maria**

87 **Rinaldi**

88 Maria Rinaldi, Community Development Director stated the 1<sup>st</sup> Annual 4<sup>th</sup> of July event in lieu

89 of fireworks display was held from 4:00 p.m. to dark at Rotary Park. Sponsorship was provided  
90 by Youth Core Conservation, Sandoval County Sherriff Posse, Army National Guard and  
91 Sandoval County Fire Department. There was a climbing wall provided by Army National  
92 Guard, fun jumper from El Paisano Rental Company, horse rides provided by Sandoval County  
93 Sherriff Posse, Sandoval County Fire Department provided a water fall of water. Over 300 hot  
94 dogs were served. The cost was less than \$750.

96 Mayor Torres thanked staff and the partners for providing this fun event for the 4<sup>th</sup> of July.

99 Mayor Torres welcomed the Public to speak with a limit of three minutes. Several members of

102 Phyllis Aris spoke about Valerie's Place, a shelter for abused women which provides them with  
103 training and education skills to be successful in life.
