**Closure of Town Operations Policy**

70 **In the Town of Bernalillo all Town Offices will consult with the Town**  
71 **Administrator including Motor Vehicle Department, Swimming Pool, Library and**  
72 **Planning and Zoning before the Director makes a decision on closure or**  
73 **dismissal. A two week notice prior to closure must be given except in the case of**  
74 **an emergency. The Town Administrator will make a decision on whether to curtail**  
75 **Town Operations. This decision will be based on the need to keep Municipal**  
76 **operations functioning as normally as possible and our concern for serving the**  
77 **Public.**

78 **The only approved Town of Bernalillo office closures are those on the Holiday**  
79 **Schedule approved by the Governing Body.**

80

81 **Closure of a Town Office without prior authorization from the Town Administrator**  
82 **may result in disciplinary action up to and including termination.**
