# ◆ CORONADO CAMPGROUND ◆

Coronado Campground is an urban campground within the historic **TOWN of BERNALILLO**, and is currently designed for *short-term* stays. Month-to-month rentals are based on availability November through March only. Located on a bluff above the ancient Rio Grande, the Campground overlooks the Bosque or river forest, the foothills beyond, and towering above all - the majestic northwest face of the Sandia Mountains. Here at Coronado Campground you share a view treasured by ancient Pueblos and Spanish conquistadors alike.

We have two camping areas, the Main Area and the North Area, offering the following accommodations and amenities:

- ◆ **RV's and Campers:** Main Area. Standard stay allowed is up to 14 days. Longer stays require prior written approval of the Campground Manager.
- ◆ **Tents:** North Area. Maximum stay length is 14 days. Longer stays are not allowed. Tent area is closed between November 1<sup>st</sup> and March 1<sup>st</sup>.
- ◆ **Picnic / Day Use:** Main and North Areas.
- ◆ **Toilets & Showers:** Main and North Areas.
- ◆ **Water:** Provided at each shelter in Main Area, and between every two shelters in North Area.
- ◆ **Electricity:** Available at each shelter in Main Area *only*.
- ◆ **Sewage:** A dumping station is provided on site.
- ◆ **Recreation:** Trail connections, a volleyball pit, and access to the river are provided on site. Coronado State Monument and Santa Ana Golf Course are located adjacent to the Campground.

### Please Observe The Following Rules To Make Your Stay Safe And Pleasant:

#### **PLEASE DO:**

- ◆ Pay each and every required Fee.
- ◆ Park any and all vehicles (including RV's) in officially designated parking areas or parking turn-outs **ONLY**. **Do not park any vehicle in such a manner as to block access, restrict traffic, or inhibit the free movement of other vehicles. Obey all traffic speed regulation.**
- ◆ Place any and all tents in officially designated tent-camping areas **ONLY**. Tents are not allowed in the RV section of the Campground.
- ◆ Keep any and all vehicles in a road worthy, well maintained, and safe condition. Keep all tents in a structurally sound, well maintained, and safe condition. Owners of vehicles or tents are **SOLELY RESPONSIBLE** for the maintenance, safety, and security of their own property. **CORONADO CAMPGROUND ASSUMES NO LIABILITY RELATED TO PERSONAL PROPERTY.**
- ◆ **Keep campsites clean and sanitary.** Pick-up any litter daily (including cigarette butts, and animal droppings), wrap securely, and **PLACE IN DUMPSTERS PROVIDED**. Keep all belongings in your designated area. Do not overrun into other campsites.
- ◆ Discharge any and all gray water / sewage **ONLY IN DUMP STATION PROVIDED**. Remove any spillage, or mess created, immediately and in a sanitary manner.
- ◆ Keep any and all children under the direct supervision of a responsible adult at all times in order to avoid potential hazards and dangers on site. Parents or guardians of children are **SOLELY RESPONSIBLE** for their safety and good discipline. Prevent children from becoming a nuisance.

- ◆ Keep any and all dogs, cats, or other domestic pets under the direct supervision of a responsible adult at all times. Owners or guardians of animals are SOLELY RESPONSIBLE for their health, cleanliness, safety, and good discipline. Keep animals out of buildings, and restrained on leashes of no more than 10 feet in length. Prevent animals from becoming a nuisance. DO NOT LEAVE ANIMALS UNATTENDED, Aggressive animals are not allowed. **ALL ANIMALS MUST HAVE CURRENT VACINATIONS, TAGS AND LICENSES.**
- ◆ Keep any and all campfires or cooking grilles under the direct supervision of a responsible adult at all times. Campers are SOLELY RESPONSIBLE to ensure that campfires and cooking grilles are used only at officially designated locations, are tended to safely and securely, and are quenched completely when no longer in use.
- ◆ Maintain and comply with designated “Quiet Hours” between 10:00 PM and 7:00 AM. Loud activities or the use of generators, outdoor radios or TV’s, un-muffled vehicles or other loud equipment, are not allowed during these times. Children and animals should also be kept at their own campsites during these hours.
- ◆ Treat your fellow campers and Campground Staff with civility and respect.
- ◆ Report any park facilities which are unclean or which are not in good operating order to the Manager.
- ◆ Notify the Manager if your property shall be left unattended for more than 24 hours.
- ◆ You are responsible for visitors to your campsite. All visitors must follow all rules.

## **PLEASE DON'T:**

- ◆ Have more than one family per campsite.
- ◆ Engage in loud, obnoxious, dangerous, disorderly, destructive, drunken, or antagonistic behavior.
- ◆ Consume alcoholic beverages in public. Alcoholic beverages may be consumed inside RV’s, campers, or tents as long as no other rules are violated by such use.
- ◆ Bring or use any firearm, other weapon, or dangerous device within the Campground.
- ◆ Use fireworks of any kind within the Campground.
- ◆ Attach, nail, or otherwise adhere anything to any Campground structures or trees, including laundry, tents, lights, etc.
- ◆ Move picnic tables outside of shelter.
- ◆ Use more than one refrigerated air-conditioner per site; Use exterior propane bottles; or, Use any radiant electric heater.
- ◆ Operate any off-road vehicles within the Campground.
- ◆ Wash any vehicles (including RV’s, tow vehicles, motorcycles, ATV’s, etc.) at the Campground. Commercial Carwashes are available in the Town of Bernalillo for your convenience.
- ◆ Have more than the maximum allowed number of vehicles per site. No more than one sleeping vehicle and one additional vehicle are allowed (if space is available). RV’s towing a vehicle, or vehicles towing a camper, will be considered as a single vehicle. Additional vehicles will require the payment of an Additional Parking Fee.

## **FEES:**

- ◆ **General Notes:** All fees shall be paid prior to entrance into the Campground. Fees shall be charged according to the utilities provided at each campsite, whether or not they are used. Failure to pay fees prior to entrance into the Campground shall result in an additional **unauthorized entrance fee of \$5.** Failure to pay any fee may result in eviction from the Campground and/or criminal action for trespass.
- ◆ **Reservation Fee:** Non-refundable \$10 fee for each camp site reserved.
- ◆ **Main Area Fee:** \$20 per day for 20/30 amp site; or, \$22 per day for 50 amp site; or, double nightly rate during the Albuquerque International Balloon Fiesta.
- ◆ **North Remote Area Fee:** \$14 per day for each shelter site; \$14 per day for each tent site.
- ◆ **Additional Parking Fee:** \$8 per vehicle per day.
- ◆ **Day Use / Picnic Fee (North Remote Area):** \$1 per hour, or \$8 per day.
- ◆ **Group Shelters (Main and North Remote Areas):** \$10 non-refundable Reservation Fee; and \$42 user Fee; and \$20 refundable damage deposit.

**The undersigned Camper acknowledges and agrees that:**

- 1) He/She has received, read, understands, and agrees to comply with each and every rule of Coronado Campground; and,*
- 2) Interpretations of the rules, and enforcement thereof, shall be at the SOLE DISCRETION of the Campground Manager; and,*
- 3) Violations of, or failure to comply with, any of these rules may be cause to refuse admittance to, or cause for immediate eviction from, Coronado Campground. Any vehicle placed in violation of these rules may be removed immediately by the Manager at the Owner's expense.*
