87 **1.0 Statement of Purpose and Need for the Proposal**

88 The proposed project is located in the Town of Bernalillo (Town), Sandoval County, New
89 Mexico. The purpose of the project is to install approximately 8,600 linear feet of replacement
90 6-inch diameter PVC waterlines and appurtenances, including gate valves, isolation valves, valve
91 boxes, and fire hydrants in the municipal water distribution system on the following streets
92 Camino del Bosque, Calle San Lorenzo, Calle Don Pedro, Calle San Ysidro, Calle Don Rodrigo,
93 and Camino del Pueblo (NM313) in order to replace aging section of old waterline in the Las
94 Cocinitas residential neighborhood.

95
96 The new waterlines would be constructed to replace deteriorating sections of old waterlines that
97 were installed 64 years ago in (1947). This grant would allow the Town to provide water system
98 rehabilitation grant assistance to the “Las Cocinitas” neighborhood, which is a low and moderate
99 income neighborhood. The project will benefit 6,611 persons of which 4,277 or 64% are low to
100 moderate income based on the 2000 HUD Census Data. The Town will provide \$50,000 or 10%
101 local cash match in addition to \$217,370.00 in leveraging.

102
103 The installation of the new waterlines would benefit operation of the water system by reducing
104 the amount of required maintenance and improving and delivery pressure to customers. The
105 water system would also have better capabilities for providing fire flow following the completion
106 of improvements.

107
108 **2.0 Location of the Proposed Project in a Floodplain or Wetland**
109 The proposed waterline replacements will occur within a designated floodplain hazard area.
110 Water line replacements are not considered a critical structure, although waterlines are seen as
111 critical in assuring proper distribution of potable water to Town residences and businesses. No
112 alternate sites have been proposed, given the location-specific needs for waterline replacement in
113 the designated residential areas. Anchoring of the water lines installations will not be necessary.

114
115 Communication with The Town of Bernalillo Floodplain Manager confirmed that the proposed
116 waterline improvements are located within either: 1) “Zone X (area of 0.2 percent annual chance
117 of flood); areas of 1 percent annual chance of flood with average depth of less than 1-foot or with
118 drainage areas less than 1 square mile; and areas protected by levees from one protected by
119 levees from one percent annual chance of flood); or 2) ‘Zone-AO – Depth 1 foot.’” A small
120 portion of the Project Area (at its northwest corner) is located with ‘Zone A’ – Special Flood
121 Hazard Area – No Base Flood elevation determined.” These designations became effective on
122 March 18, 2008, and are reported on the National Flood Insurance Program, Flood Insurance
123 Rate Maps (FIRM) for Sandoval County New Mexico and Incorporated Areas (Map Number
124 35043C-19916D).

125
126 The area of the proposed project is protected from flooding by an extensive system of levees
127 along the Rio Grande, located 0.25 miles to the west of the project area. This levee system
128 provides a mitigating circumstance that substantially eliminates the occurrence of the 1 percent

129 flood. No impact(s) of the proposed action are anticipated with respect to installation of the new
130 waterlines. However, any unanticipated impacts resulting from the proposed action will be
131 mitigated where avoidance cannot be achieved.

132

133 For the opportunity to comment on the proposed action and the Flood plain and Wetland Review
134 was solicited and advertised as required. No comment or request to review the documents was
135 received. Maria Rinaldi stated that she had Mike Castillo Engineer for ESCAFCA review the
136 document he indicated there were no issues with the Floodplain and Wetland Review.

137

138 Mayor Torres asked if anyone in the audience would like to speak or had any questions for the
139 Public Hearing on the Floodplain and Wetlands Review for CDBG Project 10-C-NR-O-01-A-07
140 Water System Improvement Phase II (Las Cocinitas).

199 **WHEREAS**, The Town of Bernalillo is committed to comply with Section 3 of the Housing and
200 Urban Development Act of 1968, as this act encourages the use of small local businesses and the
201 hiring of low income residents of the community and,
202

203 **WHEREAS**, The Town of Bernalillo has appointed Yolanda Mora, Personnel Director, as the
204 Section 3 Coordinator, to advise and assist key personnel and staff on Section 3, to officially
205 serve as focal point on Section 3 Complaints, as the on-site monitoring of prime contractors and
206 subcontractors to ensure the implementation and enforcement of their Section 3 Plans. The
207 approval or disapproval of the Section 3 Plan is the ultimate responsibility of the Town.
208 Documentation of Town efforts will be retained on file in the appropriate office for monitoring
209 by the State of New Mexico.
210

211 **THEREFORE**, the Town shall:
212

- 213 1. Hiring
214 a. Advertise for all Town positions in local newspapers.
215 b. List all Town job opportunities with the State Employment Service.
216 c. Preference in hiring will be given to lower income persons residing in the town.
217 If two equally qualified persons apply and one is a resident of the town, and one is
218 not, the resident will be hired.
219 d. Maintain records of Town hiring which list job classification, number of positions
220 to be filled, number of positions to be filled by lower income town residents,
221 number of positions filled and number of positions filled by lower income town
222 residents.
223
- 224 2. Contracting
225 a. The Town will compile a list of businesses, suppliers and contractors located in
226 the town.
227 b. These vendors will be contacted whenever the Town requires supplies, service or
228 construction to solicit bids or quotes.
229 c. Preference will be given to small local businesses. If identical bids or quotes are
230 received from a small business located within the town and one from outside the
231 town, the contract will be awarded to the business located within the town.
232
- 233 3. Training
234 The Town shall maintain a list of all training programs operated by the Town and its
235 agencies and will direct them to give preference to town residents. The Town will
236 also direct all CDBG sponsored training to provide preference to town residents.
237
- 238 4. CDBG Contracts
239 All CDBG bid packages and contracts shall include the following Section 3 language:
240 a. The work to be performed under this contract is on a project assisted under, a
241 program providing direct federal financial assistance from the Department of
242 Housing and Urban Development and is subject to the requirements of Section 3
243 of the Housing and Urban Development Act of 1968, as amended, 12 U.S.C.
244 1701u. Section 3 requires that to the greatest extent feasible, opportunities for
245 training and employment be given to lower income residents of the project area
246 and contracts for work in connection with the project be awarded to business
247 concerns residing in the project area.
248 b. The parties to this contract will comply with the provisions of said Section 3 and
249 the regulation issued pursuant thereto by the Secretary of Housing and Urban
250 Development set forth in 24 CFR and all applicable rules and orders of the
251 Department issued there under prior to the execution of this contract. The parties

- 252 to this contract certify and agree that they are under no contractual or other
253 disability, which would prevent them from complying with these requirements.
254 c. The contractor will send to each labor organization with which he has a collective
255 bargaining agreement or other contract or understanding, if any, a notice advising
256 the said labor organization of his commitments under this Section 3 clause and
257 shall post copies of the notice in conspicuous places available to employees and
258 applicants for employment and training.
259 d. The contractor will include this Section 3 clause in every subcontract for work in
260 connection with the project and will, at the direction of the applicant for, or
261 receipt of, federal financial assistance, take appropriate action pursuant to the
262 subcontract upon a finding that the subcontractor is in violation of regulations
263 issued by the Secretary of Housing and Urban Development, 24 CFR 135. The
264 contractor will not subcontract with any subcontractor where it has notice or
265 knowledge that the latter has been found in violation of regulations under 24 CFR
266 135, and will not let any subcontract unless the subcontractor has first provided it
267 with the requirements of these regulations.
268 e. Compliance with the provisions of Section 3, the regulations set forth in 24 CFR
269 135, and all applicable rules and order of the Department, issued there under prior
270 to the execution of the contract, shall be a condition of the federal financial
271 assistance provided to the project, binding upon the applicant or recipient for such
272 assistance, its successors, and assigns. Failure to fulfill these requirements shall
273 subject the applicant or recipient, its contractors and subcontractors, its successors
274 and assigns to those sanctions specified by the grant or loan agreement or contract
275 through which federal assistance is provided, and to such sanctions as are
276 specified by 24 CFR. 135.

277
278 The Town of Bernalillo will maintain all necessary reports and will ensure that all contractors
279 and subcontractors submit required reports. The Town will also require each contractor to
280 prepare a written Section 3 Plan as part of their bids on all jobs exceeding \$100,000.00. All
281 Section 3 Plans shall be reviewed and approved by the Town's Equal Opportunity Section 3
282 Compliance Officer and shall be retained for monitoring.

283 LOWER INCOME CLARIFICATION

284
285 A family who resides in Bernalillo and whose income does not exceed Eighty (80) percent of the
286 statewide median is considered by the State to be a lower income family. Information contained
287 in this Section 3 Plan reflects the status of the Town employees regarding lower income
288 consideration based on their salary paid by the Town.

289

325 NM local area market rents and determined the Fair Market Rents for Cuba, NM to be

329 WHEREAS, the Town of Bernalillo Department of Housing Services has completed a review
330 and revision of its Payment Standard for Cuba, NM for its Fiscal Year beginning July 1, 2011,
