Peddler's License Checklist

ALL THE FOLLOWING COMPONENTS ARE NEEDED TO COMPLETE PEDDLER'S LICENSE APPLICATION WITHIN 7-10 BUSINESS DAYS.

- Completed in full Peddler's License Application** (ordinance #128)
 - \$10 per day-Electrical Use
 - \$30 fee Merchandise Vendor
 - \$50 fee Food Vendor
- Tax Account Status Document** with a status of "**In Compliance**" (ordinance #260)
 - *Directions for accessing this information can be found on the next page*
- State Licenses** or Health Department Permits, if applicable:
 - Examples include:
 - Auto Mechanic License
 - Barbers License
 - Food/Health Permit
 - Doctoral License
 - Electrician License
 - Etc.
- Letters from Property Owners** you plan to peddle your goods/services from
 - more addresses can be added later once the letters have been reviewed by our Planning & Zoning Department
- Approval from the Planning & Zoning Department**
 - Once you've turned in a complete application, approval will be needed before processing can take place.

The most efficient way for your Peddler's License Application to be completed is with **fees paid in cash, check, or money order**. We do accept credit cards (Visa, MasterCard, Discover), however processing does not take place until the very end of the license application process.

*Make checks or money orders payable to: **Town of Bernalillo***

If any documents are missing, this may delay the application process.

Peddler's Licenses will be either mailed to the listed business mailing address or picked up from Bernalillo Town Hall.

- ❑ **Last 4 digits of FEIN or SSN or ITIN**
