36 **WHEREAS,** Sandoval County Sheriff’s Officer Sergeant Joseph (“Joe”) A. Harris, age 46,
37 tragically lost his life in the line of duty on Thursday, July 16, 2009 in the Jemez Mountains of
38 New Mexico;

39 **WHEREAS,** Sergeant Harris was a true advocate of community policing. He was the founding
40 officer of the Rio Rancho D.A.R.E. (Drug Abuse Resistance Education) program and also
41 participated in the G.R.E.A.T. (Gang Resistance and Training) program;

42 **WHEREAS**, Sergeant Harris is survived by his wife, Tonia, two sons, Joseph, Jr., and David, and
43 Daughter Allyson;

44 **WHEREAS**, this tragedy reminds the citizens of The Town of Bernalillo of the tremendous
45 sacrifice that the men and women of law enforcement make as they fight to preserve and protect
46 the health, safety, and welfare of Sandoval County citizens and property; and
