APPROVAL OF AGENDA: 4a)

Councilor Sisneros moved to approve the agenda as presented. The motion was seconded by Councilor Prairie and the motion carried unanimously.

PUBLIC HEARING: 5a) Discussion, Consideration and Action on Approval of Zoning Change From R-R (Rural Residential to SU (Special Use). Charles Montoya-Matthew Spangle

Matthew Spangler, agent for Charles Montoya stated the item in question was a zone map amendment from an R-R zone to an S-U zone for the real property located at 153 N Camino Don Tomas, Bernalillo, NM. Mr. Montoya received a unanimous recommendation of approval for his applicant from the Town of Bernalillo Planning and Zoning Commission after a public hearing on December 4, 2007. Planning and Zoning had request an updated site plan which was submitted in March of 2008. Planning and Zoning staff indicated the item would need to be placed on the Town Council agenda. We were informed that only the Mayor can place items on the Council Agenda. In 2008, we spoke with Planning and Zoning staff again and were assured it would be place on the Town Council Agenda.

By the beginning on 2009, we still had not been schedule for a Town Council Hearing. At that time I called the Town's Attorney Mr. George Perez. Mr. Perez assured me that the item would be scheduled for a hearing before the Town Council.

Since then we have spoken to Planning and Zoning and know it is their recommendation for this property to be zoned C-1 (Retail Commercial). We are in agreement with that zoning amendment for 153 N. Camino Don Tomas.

47 Kelly Moe, Planning and Zoning Director stated the applicant requests approval of an
48 Amendment to the Zoning Ordinance (Zone Change) for the property known as 153 N. Camino
49 Don Tomas. The intent of the request is to make the previously approved Conditional Use
50 Permit, for the current commercial use of the property, permanent in nature. The Conditional
51 Use Permit was approved by the Commission at its regular meeting of November 14, 2006; and
52 upheld by the Council on appeal at its regular meeting of December 11, 2006. The current
53 application was heard and recommended for approval (conditionally) by the Planning and
54 Zoning Commission at its regular meeting of December 4, 2007. The application did not
55 proceed to Council under the previous administration, and the applicant now seeks to have the
56 matter move forward for final consideration. Although much time has passed, I believe the
57 applicant has expressed a willingness for the Council to consider approving a zone change to C-1
58 (Commercial Retail) rather than the originally request SU (special Use).

59
60 It is the recommendation of staff to approve the amendment to the zoning ordinance to C-1
61 (Commercial Retail) due to the location of the parcel near the major intersection of Don Tomas
62 and US 550; the previous discussions and decisions of the Commission and Council; and that SU
63 zoning does not seem appropriate for the proposed use of the property as shown in the site plan
64 provided.

66 Mayor Pro Tem Jaramillo asked if anyone would like to speak for or against.

67
68 James Pike spoke in favor of the amendment to the zoning ordinance.

69
70 Mayor Pro Tem Jaramillo asked for a motion to approve the Zone Map Amendment for 153 N
71 Camino Don Tomas from R-R (Rural Residential) to C-1 (Commercial Retail).

72
73 Councilor Prairie moved to approve the Zone Map Amendment for 153 N Camino Don Tomas
74 from R-R (Rural Residential) to C-1 (Commercial Retail). The motion was seconded by
75 Councilor Sisneros.
